Re: My book: "SI Units, Conversion and Measurement Skills".

Having seen you on TV and feeling appreciation of your good work, I believe you are the only person of integrity restore the justice and stop my mental suffering. I appeal to you to make an executive action to:

- 1) stop selling my book "SI Units, Conversion and Measurement Skills" by Amazon.co.uk and Amazon.com regardless whether it is sold as "limited availability" or "buy it used".
 Reasons: a) my publisher, Minerva, UK was liquidated on July 23, 2002 and Minerva Liquidator assured all their authors (encl. p.47b) that from 8 August 2002 "the titles will be out of print" and taken off the internet. b) quality of print and editing of my book by Minerva is degrading my work. c) publishers, after learning that there are still unresolved legal problems, are not willing to re-publish the book which results in my frustration and huge financial losses.
- 2) redress the harm and to compensate me for the illegal sale of my book by Amazon.co.uk.
- 3) oblige Amazon.co.uk to disclose the number of my books sold by them before liquidation of Minerva and after their liquidation.
