THE THIRD LETTER OF DEMAND

Thank you for your fax dated 28 January 2003.

Your words and surprise that: "I am very concerned that your book appears to be available for order at Amazon.co.uk" are dishonest.

In my faxes of 28 Nov., 11 Dec, 2002 and 11 Jan.2003 to you, I complaint that my book had been printed and sold by UK distributor/s, in spite of your words to authors that the Minerva's books would be taken off Amazon on 8 August 2002. In vain! Instead you appear to be surprised!

I requested you to identify the crooks stealing my book, take firm action against them and return their unlawful profit to me for the period until the sale of my book is stopped.

And what are your words in a response? "I can only sympathize with you, ...I am not in a position to correspond further.., you will receive a report....within fifteen months". Dishonest words!

So far, you have also refused to answer my legitimate questions raised in my fax of 11 January 2003 about action taken by Minerva concerning my book. Are they too difficult to the Liquidator or they require honesty from you to me, the author?

Instead, you are informing me that you ordered my book: "I am *trying* to contact Amazon to ascertain what position is"! "However, I would be surprised that the order will be fulfilled, as stock was kept by the subsidiary which was placed into liquidation. *Details* of who purchased the stock is given in the creditors report."

I am not interested in *details* of who purchased 6 copies of my book. I sent you a proof that Amazon has been continuously selling my book and I asked you to find out how many books Amazon and other distributors have sold. Please do not try to draw my attention to *details*!

My lawyer in UK advised me that you, Liquidator, suppose to act in a civilized manner and supply me with address of your professional body overseeing your conduct, as I requested on 11 January, otherwise, it may constitute an argument against you in a court.

IF MY DEMANDS OF 28 NOV 2002 ARE NOT MET IN FULL AND YOU STILL REFUSE TO ANSWER MY QUESTIONS IN MY LETTER OF 11 JANUARY 2003, I RESERVE MY RIGHTS TO TAKE ANY NECESSARY ACTION TO SEEK JUSTICE.
